A limited number of vendors will be selected and contracts will be awarded on a first received, first considered basis. Upon approval, each vendor must provide a Certificate from the Department of Health, an Insurance certificate, a County Fire Permit and a check for \$35.00 made payable to Gloucester County Parks and Recreation Department. Concession trailers and food offerings must comply with the following descriptions:

TIME: ARRIVE NO EARLIER THAN 7 AM and DEPART NO EARLIER THAN 4 PM

Four (4) vendors will be selected as follows:

One (1) self-contained trailer, no longer than 24ft. in length, offering selections including but not limited to cotton candy, funnel cake, hot dogs, burgers, sausage sandwiches, kielbasa, cheese fries, breakfast sandwiches, and non-alcoholic beverages.

One (1)self-contained trailer, no longer than 20ft. in length, offering selections including but not limited to hot dogs, french fries, chicken nuggets, steak sandwiches, soft pretzels, fish sandwiches, cotton candy, non-alcoholic beverages and packaged candy.

One (1) trailer, no longer than 15ft in length, offering various flavors of Italian water Ice, soft ice-cream and non-alcoholic beverages but not limited to other frozen desserts.

One (1) trailer, no longer than 15ft. in length offering various types of nuts such as cashews, peanuts, pumpkin seeds, etc., chocolate covered banana's, strawberries, apples, cannoli , and fresh squeezed juices.
