

Shopping Policies

- Passengers are not to purchase more than 2-3 bags of items per trip.
- The driver will assist loading bags (less than 20 pounds) from shopping cart to baggage area. At your destination, the driver will assist unloading the bags to the curb area.
- Bags are not to be overloaded. Passengers are expected to carry their purchase from the curb to their home.
- Passengers unable to carry purchases to their door should purchase a soft side folding chair cart that can be stored by the driver in the vehicle. Carts cannot be stored in front of the passenger's seat, this is a safety hazard and is not permitted.
- Passengers who are too frail to carry their own packages home or are unable to use a cart will be encouraged to have a friend or relative accompany them on the trip or meet them at their home.

Service animals and portable oxygen are permitted. Buses with the ADA symbol are lift-equipped. Drivers are trained to assist passengers in need of help.

Department of Transportation Services (DTS) operates bus service on a three day per week basis in the rural areas of Gloucester County to provide rural residents with shopping opportunities as well as service to other locations along the route. The service is operated as a demand response bus route service. A three-day notice is required to schedule your pick-up after the application has been made. An application for country transportation is available online or by request. Advance notice requirements also apply for demand response services.
